#### **Philosophy**

- \*\* If there is a concern about a child's readiness for the program offered by St. Peter Preschool, the teacher, director and parents will meet to make a decision about the child's participation.

### **Admission Procedures**

Siblings of children enrolled at Holy Cross Academy- St. Peter School or preschool are given enrollment preference.
